June AAPL Quarterly Board Meeting Report

Montreal Quebec, Canada



The AAPL Board of Directors has just concluded our June Quarterly Board Meeting / Annual Meeting in Montreal Quebec, Canada at the Fairmont, The Queen Elizabeth. With a full slate of Directors and Committee Chair's (both outgoing and incoming), your Board thoroughly reviewed and addressed the pressing issues of our Association. AAPL now has over 21,000 members and approximately 1200 members and guests gathered in Montreal for, what was by all accounts a wildly successful 60th Annual Meeting. This year's Keynote Speaker was famed Washington Post columnist, Best Selling Author & Pulitzer Prize winner George F. Will. The educational luncheon speaker was Steve Mueller, CEO of Southwestern Energy and Ezra Levant delivered the address at the Closing Luncheon. Mr. Levant is a famed TV Anchor and author of his most recent books, "Ethical Oil" & "Groundswell". Staff Report:

Membership Renewal was a major source of conversation this guarter. As you know, due to the inability of our current Member Suite system to handle the ever growing demands of our renewals, AAPL was forced to administer the 2014 renewal program through a paper system this year which has been extremely cumbersome for our members and for the AAPL staff. However, the implementation of the new database system will be in place well before the 2015 renewals and the Board has been assured that this process will be dramatically improved with the implementation of our news system. The Board approved some recommended By Law and Policy Manual amendments in March and those Amendments were presented to and approved by the membership in Montreal. It should be noted that none of the proposed changes to the By Laws or Policy manual included language affecting AAPL's practice of running background checks as necessary to protect the integrity of the Association. Pursuant to numerous conversations with AAPL members in our region I raised this issue in numerous settings throughout the week in Montreal and the Ethics Committee, the Membership Committee, the incoming Executive Committee and the Staff will be collaborating on a joint Background Check Policy that will be proposed and discussed at our September Board Meeting. I would like to report that AAPL has never adopted a policy of universal across the board background checks. To my knowledge, this has only been used as a tool to navigate the process described in the By Laws for those people applying for membership that have been convicted of a felony or those members who have been involved in an alleged Code of Ethics and / or Standards of Practice infraction. Anyone who falls into either of those categories would require a 2/3 majority vote of the respective Committee, the Executive Committee and the Board of Directors.

Pursuant to the Board's vote in March, AAPL has transferred \$4MM in assets from the AAPL Luther King account to the Landman Scholarship Trust (LST) account which will autonomously fund, through its annual yield, all of AAPL Scholarship commitments going forward. AAPL closed the books on Winter NAPE which included 17,430 registrants and yielded a \$3,599,178 Net Profit to AAPL. Although attendance was flat this year AAPL was able to increase revenue through an improved consolidated Marketing plan and a more comprehensive NAPE accounting procedures. Winter NAPE 2015 dates are February 11th – 13th. Attendance at NAPE East was down slightly due to competing conferences hosted by AAPG, IPAA, DUG & OGIS in the same 3 week period. This is an issue that is being evaluated and one that we hope to address in the coming years. NAPE South 2014 is scheduled in Houston on August 20th – 22nd and registration is open through July 15th. NAPE remains a major profit center for AAPL and the NAPE Operators Committee is working with the AAPL Staff to ensure that costs associated with all new Regional Expo's are as efficient as possible and continue to expand as profit centers for our Association. AAPL is forecasting a 7% growth in NAPE Revenue this coming year and has realized an approximate 30% growth since the 2011 Winter NAPE. At this time, no more Regional NAPE's are scheduled and all future NAPE expansion discussions center around the international segment of Winter NAPE and potentially a NAPE International in Calgary.

Treasurer's Report:

The Treasurer's Report contains very positive news for our Association. As compared to March 31st, 2013 total assets have increased from 27,263,067 to 33,030,004 which shows an increase of 21.2%. Expenses are up, largely due to the acquisition of the new Headquarters building, increased staff to accommodate the growth of both AAPL and NAPE, the implementation of the Marketing / Public awareness campaigns and the Government Relations Program which is masterfully tracking the progress of various legislative advances affecting our industry across the nation. As previously mentioned, AAPL has closed on a new Headquarter building in downtown Ft. Worth which will be located in the former Keith Law Offices Building at 1705 West 7th Street, Ft. Worth, TX 76102. The new building will be vacated by 8/1/14 and plans are in motion to make the new building move in ready by 10/1/14. The current Headquarters building has been listed for sale at \$1.3MM and has at least one interested buyer. This is an exciting move for AAPL and will dramatically increase the visibility of our Association and accommodate the growing demands of our staff and programs. The Board approved a 2014 – 2015 Budget totaling \$2.219 MM which includes 8 additional employees at AAPL / NAPE to deal with the ever expanding demands that our growing membership, events and influence place on the AAPL Staff and the NAPE staff in Ft. Worth. Additionally, the Board approved a Capital expense Budget of \$1.405 MM that largely covers Database, IT and building improvements.

Education Report:

Numerous Educational events continue to be scheduled in our area and around the country. TAPL has hosted a WI / NRI Workshop, a Due Dilligence Seminar and a CPL / RPL Review and Exam in the past few months. AAPL has over 100 seminars planned for the 2014 calendar year with about half of those conducted so far. New seminars released in 2014 include the following: Negotiations, Title Curative & a new AAPL Ethics Program. Planning is underway for the 2015 education calendar of offerings which will include some new seminars on the oil & Gas Lease as well as a Basics of Petroleum Economics. There are 18 scheduled Field landman seminars across the country this year. The Education Committee finalized an Ethics Video which was screened in Montreal, approved by the Board and will be utilized in numerous educational settings in the coming year. AAPL will be co-hosting a joint institute with SPE which is tentatively scheduled for March 2015. Finally, Richard Rosprim has announced that he will be retiring and Susie Mason has agreed to being teaching the CPL / RPL review in the fall of 2014.

Certification Report:

The Certification Committee continues to review about 80 – 100 applications per month and has reviewed 292 CPL applications since 7-1-13; 495 RPL Applications since 7-1-13; and 649 RL Applications since 7-1-13. Currently our Association boasts 4,261 CPL's, 4,766 RPL's & 2,166 RL's. 53% of AAPL Members maintain a designation. After thorough consideration, the Certification Committee has decided to maintain the three required CPL Sponsors for CPL applications, however they will implement a procedure to accept 2 sponsors for the RPL application (only one of which must be a CPL). As many of you know firsthand the new CPL Exam has been implemented and has seen a dramatic decline in the initial pass rate. Commonly missed questions have been and will continue to be reviewed for error and content confusion and some minor corrections have been made.

Forms Report:

The 1989 HZ JOA Form is complete and available through Forms-on-a-Disk (FOAD). The 1982 HZ JOA Form revisions have been submitted to FOAD. The Model Form 610 JOA Revision Task Force is reviewing each provision but has much of the heavy lifting still ahead and hopes to have a draft out for "Peer Review" by December and a final Draft to the Board at the March 2015 Meeting. There are continued discussions regarding case law on the exculpatory clause and successor liability, and suggested revisions relating to subsequent burdens and Pugh clause terminations as joint loss or failure of title. Anyone with specific issues that needs to be addressed in the JOA review is encouraged to submit your written thoughts so that they can be funneled to the committee for review. As the new Forms Committee convenes a discussion on the practicality of our relationship with FOAD is evolving and will be revisited in the coming months.

If you haven't yet done so, I would like to encourage you to join our National Landman's Association (AAPL). Not only does AAPL offer networking, continuing education, marketing and deal making opportunities in every basin around the world, they also actively monitor and lobby for legislative and regulatory developments across the country that affect our industry. Perhaps most importantly, all AAPL members are subject to the AAPL Code of Conduct and AAPL Code of Ethics which encourage all members of our profession to act professionally and ethically in the course of our day to day business. AAPL provides avenues of continuing education and certification for its members, all of which work to ensure to the general public's well deserved trust as they encounter Landmen of the highest ethical and professional standards.


