Expectations of recipient:

- Individual(s) must attend a "healthy" number of education classes and networking events while at the event (honor system).
- Individual(s) must report back to the Board regarding his/her experience regarding the trip. Can be a simple one paragraph report.
- Cannot get reimbursed if being reimbursed by another party (aka company) for same expenses.
- Benefit will not be awarded to same member two consecutive years in a row.

Associate of the Year: Grayson Merrill Barnes



Grayson Barnes earned his J.D. from the University of Oklahoma College of Law in 2013 where he received the American Jurisprudence Award for Professional Responsibility. While in law school, he focused on oil and gas law, attended the OU College of Law Summer Oxford Program, worked in the OU Legal Clinic and heard cases at the Oklahoma Corporation Commission with a limited license to practice law. 

AAPL AWARDS UPDATE



Congratulations to Tulsa Association of Petroleum Landmen's very own Shane M. Saunders, MBA, CPL, winner of the AAPL - American Association of Professional Landmen's 2022-23 Community Service Award! Thank you, Shane, for your unwavering service to the Tulsa community and to our beloved profession!

Shane M. Saunders, MBA, CPL is the first person that comes to mind from TAPL's organization when it comes to Community Service. Shane has been involved with Iron Gate for almost a decade and has served as Director and Board Chairman. Iron Gate's mission is simple—they feed the hungry of Tulsa, every day, through a soup kitchen, grocery pantry, and kid's pantry. Anyone served by Iron Gate is considered a "guest" because they are invited to eat. Their philosophy is: "We are all guests on this earth and guests treat one another with courtesy, kindness and respect." Shane led this organization through a long battle with downtown property owners to find a new and better location in order to serve more "guests". After 12 months in the new facility, and during the difficult and restrictive times of COVID, Iron Gate has served 22% more meals and provided 30% more groceries to those in need. Shane is at the heart of this organization. While serving as External Affairs Director for the TAPL, he has encouraged TAPL members to serve as volunteers through Spring Service days, as well as individually.

As a land professional, Shane has extensive background as an executive and as a land manager in acquisitions and divestitures in the oil and gas industry. He also has a great track record in government affairs and policy. His skills include partnering with investors, media, government, and regulatory agencies. One of his greater strengths is the ability to guide assignments from initial planning to final delivery while maintaining budgets and schedules.

As the current President of Trident Energy, Inc., Mr. Saunders manages the operations of an independent exploration and production company with producing assets in 8 states and non-operated interests in over 200 oil and natural gas wells. He guides lease acquisitions and analyzes traditional and emerging oil and gas trends to grow revenues; he forms relationships with industry partners to initiate successful oil and gas wells.

During his time at Trident, they have bought 4 competitors during favorable pricing environments, worked on a large Central Oklahoma water-flood project and various CO2-flood projects in Western Michigan, bringing formerly unrecoverable oil to market.

After receiving his BA from Washington and Lee University, Mr. Saunders worked in Washington D.C. for over 3 years as the Legislative Assistant and, later, Press Secretary for Congressman John Sullivan. There, he learned valuable skills that served him well, not only in the oil and gas industry, but in his ongoing humanitarian efforts to meet to the goal of poverty alleviation for those in need of food and nourishment.
