#### AAPL DIRECTOR'S REPORT FOR THE TULSA ASSOCIATION OF PETROLEUM LANDMEN

Coral Gables, Florida – September 10, 2023

The AAPL Board Meeting was held at the Loews Coral Gables Hotel in Florida. The following notes are only a portion of the Board Meeting. Should any member like to discuss more in detail, then please feel free to reach out to me.

#### AAPL By The Numbers – Membership is trending on pace with last year.

- At the time of this report, there are currently a little over 9,000 total members of AAPL.
- 4,228 members are certified as of 6/30/2023.

#### Education/Events

- The Education Development Committee has selected five (5) topics to expand into new 4 to 6 hour course content. These will include *Complex Contracts*, *Due Diligence*, *Royalty Calculations*, *Leadership* and *Geology and Engineering for the Landman*.
- The committee is also collaborating with other associations to develop webinars on additional topics. Specifically, the International Right of Way Association and the Texas Blockchain Council.
- In addition, the committee is working with the Texas Real Estate Commission ("TREC") to develop a series of webinars that are designed to satisfy TRECs CE requirements for licensed ROW agents.

#### Financials

The AAPL Board continues to be mindful of providing excellent member benefits while ensuring we stay within a balanced budget. The following are accounts associated with the AAPL and the dollar amounts as of 6/30/23:

- Total Assets = \$40,775,171 (up from \$39,338,051 as of 6/30/23) +3.7% Y/Y
- AAPL, Inc's Investment Accounts = \$32,435,133 (up from \$31,519,133 as of 6/30/23) +2.9% Y/Y
- AAPL Educational Foundation, Inc. = \$5,076,244 (up from \$4,876,642 as of 6/30/23) +4.1% Y/Y
- Landman Scholarship Trust = \$9,162,450 (up from \$8,674,941 as of 6/30/23) +5.6% Y/Y

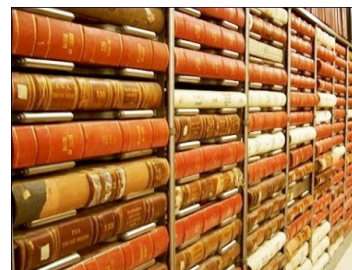
