2005-2006: Landman for Associated Resources, Inc.


2006-2007: Landman for Meridian Resource Corporation

### US Oil Drillers Add Rigs for Second Time in 2016: Baker Hughes

REUTERS—U.S. energy firms this week added rigs drilling for oil for the second time this year, energy services company Baker Hughes Inc said on Friday, after crude prices briefly tested a seven-month high over \$50 a barrel over the past two weeks.

That was a key price level that analysts and producers had said would likely trigger a return to the well pad.

Drillers added 9 oil rigs in the week to June 3, bringing the total rig count up to 325, compared with 642 a year ago, Baker Hughes said in its closely followed report.

The new rigs were scattered across many basins and states with the Permian in West Texas and New Mexico gaining five, while Alaska and Texas gained three each.

Prior to this week, energy companies added only one rig so far this year, during the week of March 18. They had cut on average 10 oil rigs per week for a total of 220 so far this year.

They cut on average 18 oil rigs per week for a total of 963 in 2015, the most since at least 1988 amid the biggest rout in crude prices in a generation.

The rig count has dropped since hitting a peak of 1,609 in October 2014 as U.S. crude futures fell from over \$107 a barrel in mid-2014 to a near 13-year low around \$26 in February.

Since then, U.S. oil futures have jumped by about 90 percent, breaking through the \$50 mark earlier this week.

Oil prices, however, were headed for a near 2 percent loss this week due in part to the rig count increase and on earlier signs the market was moving back to more balanced supply and demand after a series of supply disruptions, ending three consecutive weeks of price gains. [O/R]

Looking ahead, crude futures were fetching nearly \$50 for the balance of 2016 and over \$51 for calendar 2017.

U.S. oil executives and analysts have said any price rise above \$50 could fuel a resurgence in new drilling projects.

Analysts at U.S. financial services firm Raymond James said this week they believe the U.S. total natural gas and oil rig count is at or near the bottom and a modest recovery is in store for the back half of 2016.

This week's increase in total gas and oil rigs to 408 was the first gain since August, according to Baker Hughes.

### Oil Hits 2016 High, Driven by Falling Supply and Weaker Dollar

REUTERS—Oil prices hit their highest in eight months on Tuesday, buoyed by the dollar nearing one-month lows and by falling Nigerian oil output after a spate of attacks on infrastructure.

Brent crude futures LCOc1 were up 36 cents on the day at \$50.91 a barrel by 1339 GMT, having hit an intraday peak of \$51.30 earlier in the day, their highest since October.

U.S. crude oil futures CLc1 gained 32 cents to trade at \$50.01 a barrel, having touched a fresh 2016 peak of \$50.37, their highest since October last year.

The price of oil has nearly doubled since January, when it hit its lowest since late 2003, boosted largely by a spate of unplanned outages that have eroded production in Canada, Venezuela, Libya and Nigeria, along with a steady decline in higher-cost U.S. shale output.

Yet analysts say the rally may entice some shale production back online, potentially damaging the prospects for a more sustained price rise.

"I think that is a bit of a risk right now," Petromatrix analyst Olivier Jakob said.

"Last year, there was also a rally into June and that came to an end when the U.S. rig count started to increase ... if we have another increase this week and another next week, then it will be harder to sustain the rally because there will be a perception that we're back to production economics," he said.

Market watchers are bracing for signs of a pick-up in U.S. oil production after weekly data from Baker Hughes showed U.S. drillers added rigs for only the second time this year, analysts said. RIG-OL-USA-BHI

Helping to reinforce Tuesday's price rise was preliminary work to restart three of Total's (TOTF.PA) French oil refineries, stopped as part of nationwide strikes.

"With Brent staying above \$50, oil is on an upward momentum with the restart of French refineries that were shut on strikes and pipeline attacks in Nigeria," said Kaname Gokon at brokerage Okato Shoji in Tokyo.

Nigeria's Bonny Light crude output is down by an estimated 170,000 barrels per day (bpd) following attacks on pipeline infrastructure, according to one source.

Oil, along with the rest of the commodities complex, has also been supported by a weaker dollar.

Federal Reserve Chair Janet Yellen has indicated the U.S. central bank will raise interest rates, but has not given a sense of when. [USD/]

U.S. commercial crude oil inventories likely fell by 3.5 million barrels last week, marking a third straight weekly drop, a preliminary Reuters poll showed. The data by the American Petroleum Institute is due out at 2030 GMT. [EIA/S]

### Senate Passes Legislation Tailored to a Modern Energy Landscape

NY TIMES—The Senate on Wednesday passed the first broad energy bill since the George W. Bush administration, a bipartisan measure to better align the nation's oil, gas and electricity systems with the changing ways that power is produced in the United States.

The bill, approved 85 to 12, united Republicans and Democrats around a traditionally divisive issue — energy policy — largely by avoiding the hot-button topics of climate change and oil and gas exploration that have thwarted other measures.

Its authors, Senators Lisa Murkowski of Alaska, chairwoman of the Senate Energy Committee, and Maria Cantwell of Washington, the panel's ranking Democrat, purposely stepped away from any sweeping efforts to solve or fundamentally change the nation's core energy challenges.

Still, the measure, known as the Energy Policy Modernization Act, would respond to the rapidly transforming energy landscape. It includes provisions to promote renewable energy, improve the energy efficiency of buildings, and to cut some planet-warming greenhouse gas pollution.

It would also speed the export of domestically produced natural gas.

House and Senate negotiators will now try to forge a compromise between the Senate bill and a similar measure that passed the House last year.

Passage would represent the first time since 2007 that a significant energy bill reached the White House for the president's signature.

"What we'll be moving now is what was achievable in the Senate," Ms. Murkowski said in an interview. "Most people thought we couldn't achieve anything, but we have demonstrated that we can legislate — and we can even legislate, oh my gosh, in an election year."

Since passage of the last major energy law, the United States has gone from fearing oil and gas shortages to becoming the world's leading producer of both fuels. The use of wind and solar power is accelerating as those sources become cheaper than fossil fuels in some parts of the country. And President Obama's environmental regulations are reshaping power systems as electric utilities close coal-fired power plants and replace them with alternative sources.

But the nation's energy infrastructure has not kept pace with those changes.

The bill would promote renewable energy by requiring operators of electricity lines, transformers, and other elements of the electrical grid to upgrade the system, with a focus on large-scale storage systems for electricity to better accommodate the expanding production

of wind and solar power. The bill would create and strengthen several programs devoted to improving energy efficiency in buildings.

It would also deliver a long-sought victory to conservationists by permanently authorizing the national Land and Water Conservation Fund, a program for protecting and maintaining national parks and wilderness sites.

It would give a victory to fossil fuel producers by requiring the Energy Department to accelerate approval of permits to build coastal terminals for shipping American natural gas abroad.

And it includes provisions to address the threat of cyberattacks on the nation's electrical grid.

"There's so much change going on in the energy sector now, we need to have an energy bill every year," Ms. Cantwell said. "The speed of the transition in energy now is like telecom in the '90s."

The bill has drawn support from a wide range of business and environmental groups, including the United States Chamber of Commerce, the Alliance of Automobile Manufacturers, the Alliance to Save Energy and the Pew Charitable Trusts.

But some environmental groups offered only grudging responses to the measure.

"This bill is the V.H.S. tape of climate policy: tolerable in the '80s or '90s, but not in tune with the scientific realities of 2016," said Jason Kowalski, the policy director for 350.org, an environmental advocacy group that led protests against the proposed Keystone XL oil pipeline between Canada and the United States.

"We need Congress to get with the times and stop writing bills that prop up the fossil fuel industry that's wrecking our climate," he added.

Ms. Murkowski acknowledged that almost no one is completely happy with the measure.

"To have a bill that everybody likes is not only unusual, it's just not going to happen," she said.


The measure came to the Senate floor in January, but it stalled for three months after Senator Debbie Stabenow, Democrat of Michigan, sought an amendment to provide \$600 million to aid the victims of lead poisoning in Flint. Mich., and deal with the ongoing water crisis there. Republicans opposed her.

Last week, Ms. Stabenow and a handful of other senators relented and lifted their blockade of the energy bill.

Ms. Stabenow said that she would continue to push for a vote on the Flint aid.

### **MURRY BYRON ATTERBERRY (1934-2016)**



Murry Byron Atterberry passed away peacefully on Monday, February 22, 2016, in Tulsa, surrounded by his wife and loving family. He was 81.

Murry was born August 3, 1934 in Ralls, TX, the youngest of seven siblings to Louie Cass and Jessie Lee Atterberry. He moved to Pawhuska at the age of nine and worked for the Journal-Capital as a carrier, where he earned high praise, winning his prized bicycle for Best Carrier.

Murry graduated from Pawhuska High School in 1953, attend college and played football at Northern Oklahoma Junior College in Tonkawa and Northwestern State College in Alva, graduating in 1957 with a Business Degree. While still in college, Murry married his high school sweetheart, Lavelle Standifer, on June 10, 1956.

After seven years, Murry was able to get back to Oklahoma when he became Vice President of the Land Department with Andover Oil Company in Tulsa, where the family settled and remained ever since.

Murry has been an officer in the American Association of Petroleum Landmen and an active church member at all of his stops, eventually leading him to his present church, Redeemer Covenant. Murry loved playing golf, singing in the choir, playing Bridge, Traveling and attending the many events of his six grandchildren.



## IN MEMORIAM

### **EDWIN KRONFELD (1931-2016)**



Edwin Kronfeld [1931-2016] passed away Saturday, February 13, at St. John Hospital of Tulsa, after falling from a ladder while reaching for a jazz album to play during a dinner at home. Ted was born on June 28, in New York City, N.Y., to Aaron and Naomi Kronfeld. He graduated from the Bronx High School of Science, attended Harvard University and graduated from Harvard Law School. Ted was proud to have been one of the top Fuller Brush and Electrolux salesmen in New York City while he was in college. Ted later received a Master's of Laws in taxation from the Georgetown University Law Center. Upon his graduation from law school, Ted went to work for the U.S. Securities and Exchange Commission in Washington DC. While there he met his beloved wife of 56 years, Lydia (Bebe), who was a physician doing her residency at Saint Elizabeth's Hospital. He later joined the international law firm of Morgan, Lewis and Bockius LLP, where as a partner he counseled numerous clients in corporate and


regulatory matters. Ted also taught as an adjunct professor in corporate law at the Georgetown University Law Center. After establishing himself as a distinguished corporate lawyer in Washington DC, Ted sought further challenges and in 1979 he moved his family to Tulsa, Oklahoma to pursue an entrepreneurial dream. The Harvard-educated, DC corporate lawyer from humble beginnings in New York City sought to become an Oklahoma oil man. Ted founded Plymouth Resources, a natural gas investment firm, and after many years in the energy business, launched Plymouth Exploration, an oil and gas exploration and production firm. At 83, Ted successfully led Plymouth Exploration to its acquisition by an international conglomerate. Even after completing what for most men would have been more than enough achievements for a lifetime, Ted continued to look for new deals and challenges, working as he always planned, until his death. In addition to the law and business, Ted had a passion for music and the arts. He served as Chairman of the Board of the Tulsa Philharmonic, where he introduced the concert series, "Jazz with Class", an effort to make art music appealing to a wider and younger audience. Ted actively supported Chamber Music Tulsa, the Tulsa Symphony, the Tulsa Ballet and Tulsa Opera, as well as the McFarlin Library at T.U. He spent many wonderful summers with his family in Aspen, Colorado where he and his wife attended the music festival for 20 years. Ted also loved wine. He was a passionate collector and deep source of knowledge on the subject. He shared generously with friends and family from his extensive cellar and promoted goodwill among those fortunate to be at his table. In addition to his wife, Ted is survived by three children, Nicholas Kronfeld and his former wife Maria of New York City, Alice Fernelius and her husband Steve of Houston, and Alexander Kronfeld and his wife Randa of Tulsa, as well as nine grandchildren, Georgina, Madeline and Miranda Kronfeld; Nicholas, Caroline, Katherine and Jackson Fernelius; and Chase and Tennyson Kronfeld.
