Letter From the President

Dear Members,

February is a busy month for our Association. Of course, many of our members will be attending the Winter NAPE Expo in Houston the first week of February. We also have the TAPL social to be held on February 10th at the Oklahoma Aquarium in Jenks, as well as two AAPL courses to be hosted here in Tulsa.

The first AAPL course, "Working Interest & Net Revenue Interest Calculation Workshop" will be held at Tulsa University on Saturday, February 5, 2014. This workshop is a great introductory course intended to equip land professionals with elementary skills for working interest and net revenue interest calculations. Instruction is limited to NRI and WI calculations which may be found in leases, assignments, operating agreements and associated documents. For anyone just entering into the business, or needing a refresher, this is a great course to attend.

The second AAPL course is the "Oil and Gas Review and RPL & CPL Exam", which will be held at the Marriott Southern Hills beginning February 25th through February 28th. If you are in need of your AAPL credits, this is a "one-stop-shop," with up to seventeen (17) general credits, plus one (1) ethic credit available. The Oil and Gas Review's primary purpose is to prepare each landman for the CPL or RPL exam. The course covers many of the areas that a landman might become involved in over a career. This course is also a great opportunity for anyone interested in a general review.

I am grateful for the wonderful opportunity to have these courses hosted here locally, but having successful attendance is paramount in having Tulsa continue to host similar courses in the future. Therefore, I would encourage you to consider attending one or both courses, as your schedule permits. Having personally attended each of these courses in the past, I can attest to the value each course can have on your own personal career.

While education is vital to improving our own abilities within the industry, equally important is the impact we are able to have on those just entering into this great industry. As some of you may not be aware, the TAPL has a growing influence on our next generation of landmen through the TAPL/TU Mentoring Program. 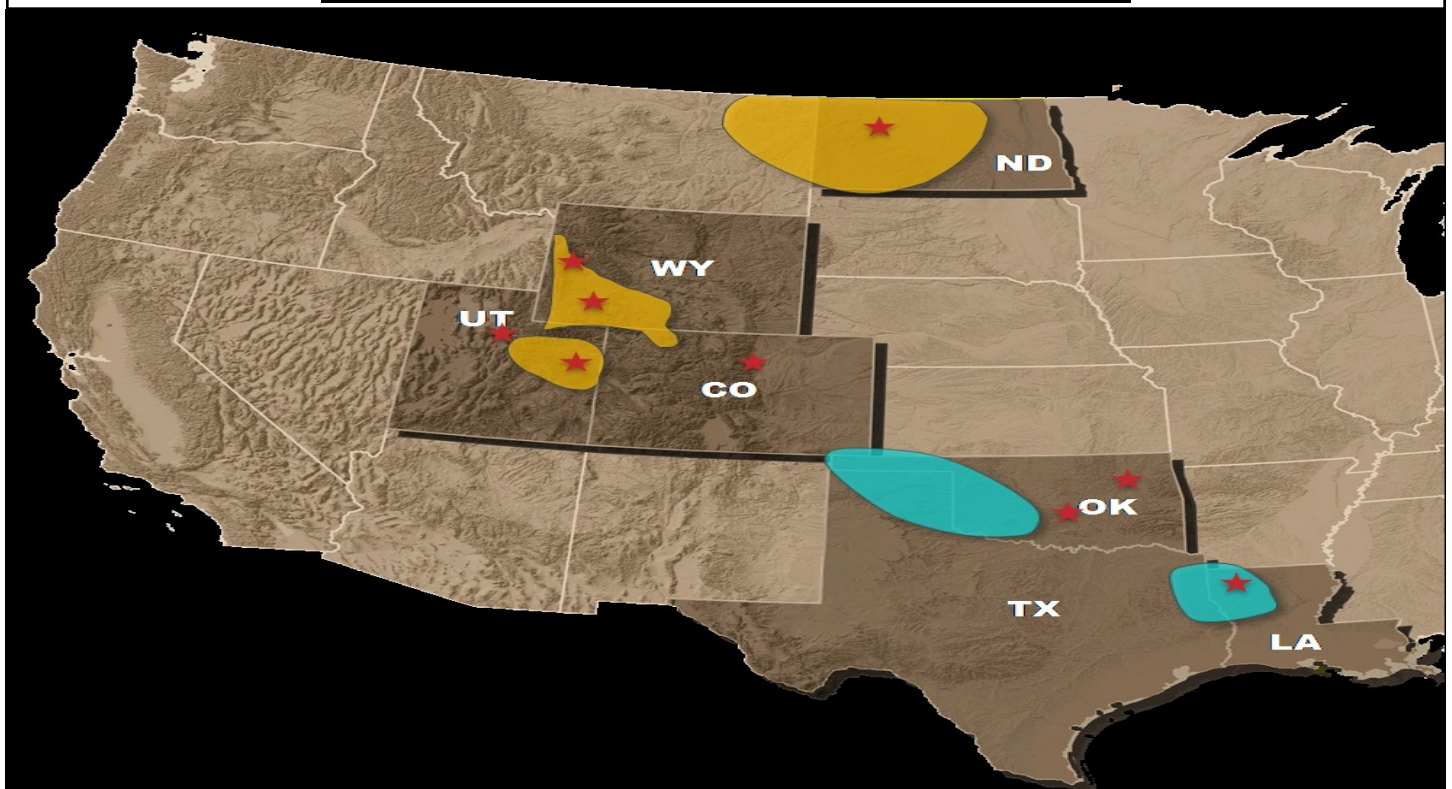

I believe that TU's Energy Management program does a great job of providing students with a solid foundation from which to build their knowledge base in the oil and gas industry, and most importantly, trains students how to think through and evaluate scenarios that they will encounter once they join the workforce. It has been my experience that the oil and gas industry, especially as it applies to landmen careers, cannot be fully taught in a classroom. This is why I believe it is so beneficial for students to have a mentor that can help guide them through the earliest stage of their careers. Their careers start while they are in college and are participating in internship programs and trying to decide what part of the oil and gas business they would like to pursue. To me it is invaluable for students to be able to develop a relationship with an experienced landman during this time who can answer the questions that they have about the industry they are getting into.

Over the course of my career, I have been blessed to have very talented mentors who took time to invest in me and my career, and I am forever in their debt for it. While I attended the University of Oklahoma, I was a mentee in a similar program to the TAPL-TU Mentoring Program, and I received the benefit first hand of having an experienced Landman be my mentor while I started my career. My mentor in that program was David Salter, Land Manager for Mustang Oil and Gas. Outside of the meetings put on by the program, David took me to other industry events, like OCAPL meetings, golf and sporting clays tournaments and introduced me to numerous Landmen. David also always made himself available if I had land questions arise during my internships. David was (and still is) a great mentor to me and is one of the main reasons why I joined the TAPL-TU Mentoring Program. I wanted to try and give back to some of the TU students some of the benefits I enjoyed as a mentee in a mentoring program.

This is my second year as a mentor in the TAPL-TU Mentoring Program. This program provides a great platform for students to hear from experienced landman who work in many different areas within the oil and gas industry. Each meeting has a speaker that talks about their career and gives personal insight to the students. We have had Field-Landmen, In-House Landmen, A&D Landmen, Offshore Landmen, and on a special occasion one of the mentee's took the initiative to secure congressmen Jim Bridenstine as the guest speaker. Outside of the meetings, one of the mentors Don Hansen has been generous enough to host the entire TAPL-TU Mentoring Program to 4 or 5 sporting clays shoots at his personal farm where he and other mentors taught the students to shoot while also providing great networking between the students and mentors. Jake Bebermeyer is my mentee. He is a senior at TU and has secured an internship for this upcoming summer. This is Jake's 3rd internship, and he plans to graduate next December. I try to meet up with Jake at least once a month, inviting him to lunch and bringing other landmen that I work with both at Apache and at other companies so Jake can begin creating his own network of contacts within the industry. It has been very rewarding and I now consider Jake a good friend that I will keep in touch with after he graduates from TU and this mentoring program.

The majority of us in this industry have been fortunate enough to have a mentor who invested their time and energy so that we could succeed in our careers. Production from Olympus Platform in U.S. Gulf Begins

Royal Dutch Shell plc has initiated production from the Mars B development through Olympus, the company's seventh and largest floating deepwater platform in the U.S. Gulf of Mexico.

Mars B is the first deepwater Gulf project to expand an existing oil and gas field with significant new infrastructure, which Shell said should extend the greater Mars basin's life to 2050 and beyond. Future production from Olympus and the original Mars platform should deliver 1 billion barrels of oil equivalent (boe).

Shell safely completed construction and installation of Olympus more than six months ahead of schedule, allowing Shell to begin production early on the development's first well, said John Hollowell, executive vice president of deepwater, Shell Upstream Americas, in a Feb. 4 press statement. "With two large platforms now producing from the deepwater Mars field, this project demonstrates our deepwater project delivery and leadership," Hollowell commented.

The Shell Mars B development includes the Olympus drilling and production platform – located in approximately 3,100 feet (945 meters) of water -- subsea wells at the West Boreas and South Deimos fields, export pipelines, and a shallow water platform at West Delta Block 143 close to the Louisiana coast. Shell is operator of the Mars B development with 71.5 percent interest. BP plc holds 28.5 percent interest.

The Mars, Deimos and Europa fields are located on Mississippi Canyon Blocks 762, 763, 806, 807, 850, 851 and 935. The fields are all tied-back to the Mars tension leg platform (TLP) on Mississippi Canyon Block 807, according to Rigzone's field development database, SubseaIQ.

Shell expects its wholly-operated Cardamom project in the Garden Banks area of the U.S. Gulf to begin production this year. Cardamom will be tied-back via subsea to the Shell-operated Auger TLP in Garden Banks Block 426. Cardamom is expected to produce at a peak rate of 50,000 barrels of oil equivalent per day (boepd).

Work also is underway on the 50,000 boepd, deepwater Stones development following the project's final investment decision in May 2013. The field's first phase of development will consist of two subsea wells producing to a floating production storage and offloading vessel; its production capacity will be boosted by six more development wells. Production from the field is expected to peak at 50,000 boepd in the first phase of development.

The Stones field is located at Walker Ridge Block 508 in 9,576 feet (2,919 meters) of water approximately 200 miles (322 km) offshore Louisiana. Shell is operator of the Stones development with 100 percent interest.
