During April's Executive Night & Awards dinner meeting, the recipients were presented with their new titles and plaques of honor. In case you were unable to attend, or if you would like to get to know our Awardees a little bit better, you are encouraged to please read on:

COMPANY OF THE YEAR AWARD: CASILLAS PETROLEUM CORPORATION

By means of the Company of the Year Award, TAPL expresses its gratitude and collectively recognizes one company in particular that has made an outstanding effort towards TAPL's organizational goals and has been a charitable supporter of TAPL as a whole, be it through generous event sponsorships or encouraging its employees to become involved within TAPL. This year, Casillas Petroleum went above and beyond, so on behalf of TAPL's membership, we thank Casillas for all of their contributions and support!

Casillas Petroleum Corp. was founded in 1986 by Greg Casillas. Its headquarters are located in Tulsa, Oklahoma with field offices in Lindsay and Nash Oklahoma and Satanta, Kansas.

Casillas currently employs 30 people in the Tulsa office, two of which are TAPL past presidents (Lawson Vogel and Tony Cervi) and has an additional 35 employees throughout its field offices.

Casillas operates approximately 1,000 wells in the Mid-Continent region and has two active drilling rigs in SCOOP.

In 2014 Casillas purchased Cimarex Energy Co.'s legacy Hugoton assets. Additionally, in 2016 Casillas in partnership with Kayne Anderson Energy Funds acquired two assets in SCOOP from Chesapeake and Continental for a combined purchase price of approximately \$400MM. Casillas now has 45,000 net acres in SCOOP.

Casillas' commitment to Tulsa and the energy industry runs deep and is demonstrated with its continued support and participation in the local associations, including TAPL, TGS, and SPE.

LIFETIME ACHIEVEMENT AWARD: DEBRA LANGLEY

Since its inception, this distinguished award has been the memberships' way to recognize one Landman that has contributed countless hours of their time, donated insurmountable energy, offered their adroit and innovative expertise, mentored the upcoming generations of Landmen, and selflessly orchestrated a multitude of organizational efforts -- all in the name of TAPL. With endless respect, this year's award deservedly goes to Mrs. Debra Langley. In the words of those that know her best, her career and accolades are signatory of a true trailblazer:

Mrs. Langley has over 30 years of experience in the Oil and Gas Industry. She began managing land departments at Avanti in 1980 as Vice President of Land and has continued her growth and experience with high profile companies such as Oxley, Home-Stake, Cimarex, Weinkauf Petroleum, Petroquest and is now leading a land staff of 11 employees, plus contractors at Rimrock Resource Operating as the Vice President of Land. Debra has worked in the mid-continent in every aspect of land and its related exploratory efforts with vast experience in each phase of new drills as well as workovers and recompletions. She has provided numerous hours of expert testimony at the Corporation Commission and moved with the industry into the horizontal drilling world in 2010. Currently, she is leading her land team to develop and enhance properties to increase value for Rimrock, who is a private equity startup. Debra was on the "original Rimrock team" which started in 2014 to obtain funding for this successful venture.

Debra graduated from Langston University with a degree in Business Administration. Throughout her career, she has maintained her membership in their American Association of Petroleum Landmen and served 2 terms on the Board of Directors. She achieved her Certification as a Petroleum Landman in 1992 and has continued to acquire all credits necessary to maintain that certification. In 1999, Debra was elected the first female president of the Tulsa Association of Petroleum Landmen, and has served in numerous other roles such as Secretary and Treasurer along with chairing various committees.

Mrs. Langley is very committed to her family and her community. She is actively involved in Rotary having served on the Board of Directors of the Rotary Club of Sand Springs for multiple terms. She is a long-time member of St. Matthew's Episcopal Church and has served on the vestry in many capacities.

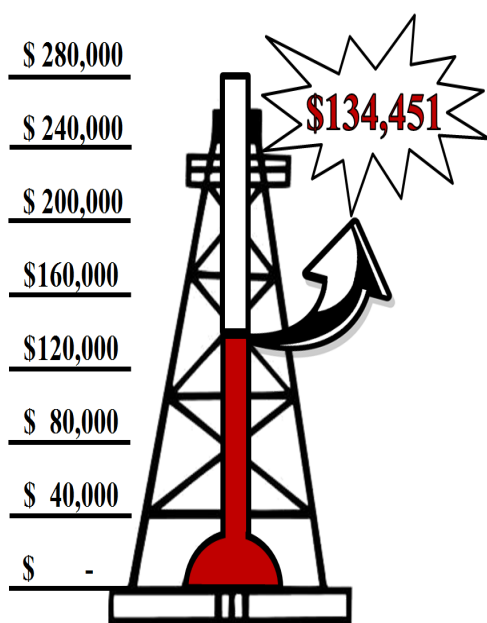

The Scholarship, Endowments and Awards Committee believes that it would be great for our members to see how these scholarship dollars are being invested and the “payout” of those investments in terms of the successes of our chosen scholars (*e.g. see Eric Weidemann’s award bio in the preceding!*). Plus, it’s a good way for everyone to ‘get to know’ the next generation of land professionals!

Furthermore, the TAPL Scholarship, Endowment and Awards Committee would like to give all members a brief update on the OU & TU Scholarship Endowments, as such is thematically illustrated in the graphic to the left. As you can see, the goal of \$280,000 would enable TAPL to annually disburse \$10,000 in multiple scholarships to OU & TU Energy Management students. Since 2013, all contributions presently add up to a booming total of over \$134,000!

Of the total funds in the endowments, over \$14,200 of that was raised in 2016. So far in 2017 alone, there has been over \$12,000 contributed to the endowments account (*included in the total*) through TAPL fundraisers! We are obviously off to a fantastic start this year and this undoubtedly attests to our chapter's generous spirit, charitable nature and all the hard work put into organizing new events such as the Flying Tee in March and the TAPL Land Run in April. Likewise, our annual TAPL Spring Scramble in May was a huge success as well– over \$7,100 was raised through donations, raffles and the buying of mulligans!

Moreover, since the inception of the Century Club, membership has cumulatively raised \$47,500 – all of which has greatly boosted the fundraising efforts of the

OU & TU Endowments (*also included within total depicted above*)! For those that may not be familiar, **TAPL's Century Club**, has been established in efforts to recognize and honor those loyal, longtime TAPL members. By way of exclusive induction, the Century Club is comprised of distinguished members and member companies that have gone above and beyond by making a \$100.00 donation to the Scholarship Endowment fund for every year they have been a member with the TAPL, or for those companies that give over \$10,000.00 to the Scholarship Endowment fund (5 year minimum for eligibility – sorry rookies!).



Example: 10 years of TAPL membership = 10 x \$100 = \$1000 for Century Club admittance

The Committee is also working on some added perks for those members apart of the Century Club; that in which will further designate them as being one of TAPL's most prominent, experienced, charitable and esteemed members – first being custom designed lapel pins, as seen to the right. If you see a member wearing one of these, you will “know” who they are!

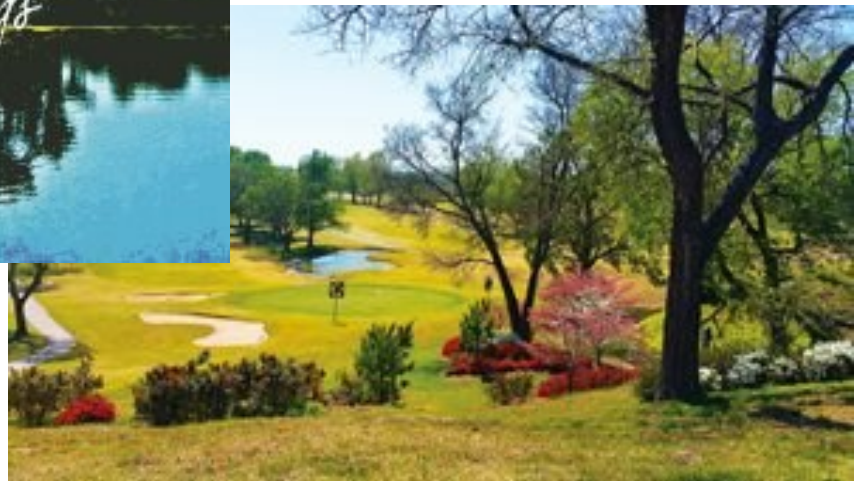

AAPL Board of Directors Meeting Quarterly Report

Seattle, WA June 23, 2017

Board Meeting Summary and Highlights

Seattle, Washington was the site of the Board and Annual Meeting for AAPL this year and believe it or not, the weather was beautiful the entire time! No rain, no overcast and the temperatures were actually a lot warmer than normal which was great for sight-seeing, golfing and taking advantage of all that Seattle had to offer! Great for golf on a lush green course with cool temps in the mornings and evenings.

The number of members, 485, and others paid and attending, 118, was well over what was needed for AAPL to break even (300) and we should make money which is far better than we could have hoped for given the carnage last year with our meeting in Orlando and given that as of the day this report is written, oil prices were near their lows for this year! Hopefully prices will cooperate and head back up pretty soon so that next-year's Annual Meeting will have as good as if not even better attendance.

Speaking of, as a "Heads-Up" call to everyone, please keep in mind and make plans for next year's **Annual Meeting in 2018 which will be at the Sheraton Denver Downtown Hotel**. For those of us who work in the Mid-Continent area, Denver is fairly easy and economical to get to and is very "oil and gas friendly". Past Annual Meetings there have always been fairly well attended so that should work nicely for AAPL's 2018 attendees. If you can arrange some sort of business call/meeting with a client or partner company in some play that a Denver-based company is working in with you and your company it will be a good economic opportunity to take part in a "twofer", i.e., kill two birds with one stone (trip) that can be better justified to your boss also!

Seattle Annual Meeting Highlights

As is normally the case, AAPL's Executive Committee was officially changed to the newly elected and approved committee members after the Board Meeting was over and was on Friday at the official Annual Meeting Business Luncheon. The Executive Committee went from President Pam Feist (our first woman President) and her crew to David Miller and his Committee members.

As you should know, our own TAPL member, Hamel Reinmiller is one of the incoming "Ex-Com" members and will be serving as Secretary. As you should also know, his task, along with the other Ex-Com members (and other AAPL volunteers such as Board Members, Committee Chairs and Assis.-Chairs) takes a significant time and monetary contribution of each to successfully run our \$30+ Million strong organization and make things continue in the right direction. Since I have been an AAPL member for around 40 years, who is and has been very involved in both Committee and Board work for many of those years, along with being friends with many others, I have quite a bit of insight into the time and cost numbers, and even in normal years, (ones with no major issues) it is staggering.

I would encourage you to pass on Kudos to Hamel and thank him next time you see him. I would estimate that an Ex-Com member will normally spend a minimum annually of 20 days of uncompensated work time (a full month of "work days") and spend close to \$20,000 of their (or their company's) money in attending the meetings that are involved. Some committee people spend even more time than that as well as a similar amount of money. Board members like I probably get off with less time spent (10-12 days average is my experience) but are out similar sums economically. In any event, when and if you get a chance, please spread around your thanks when you see those who represent us with AAPL like Hamel.

NAPE Summit 2017 Status

Attendance numbers were good and pretty close to last years in Houston. We made some serious money on it since we have changed up our staffing, outsourcing and cost-cutting. Between our Management Fee income and our share of sales, AAPL netted around 2.7MM. While Denver NAPE was not a money maker and been discontinued for now, the Houston NAPE, both summer and winter, is still a money maker for AAPL.

AAPL Treasurer's Report

Following are general reports regarding the financial condition of the American Association of Professional Landmen, Inc.:

1.Statements of Financial Position

As compared to March 31, 2016, total assets have increased from \$29,078,330 to \$30,074,690; a change of \$996,360 or 3.4%. Total liabilities as compared to March 31, 2016 have decreased from \$2,369,247 to \$1,426,826; a change of \$942,421 or 39.8%.

This is primarily due to the repayment of the \$1,000,000 building note payable. There are temporarily restricted funds in the amount of \$15,900 for three grants from the AAPL Educational Foundation to AAPL for speakers at the AAPL annual meeting and for the development of a JOA Seminar.

2.Statements of Activities

Revenues (exclusive of investment revenue) compared to March 75, 645⁰ have decreased from £6,^{3 2 2},794 to £6,87³,92⁵, a change of \$548,769 or 18.4%. The decrease in revenue is due to a reduction in NAPE distributions and management fees, a reduction in educational seminar fees and a reduction in member dues.

NAPE distributions and management fees decreased \$300,355 (34.8% reduction from \$863,666 to \$563,311), which resulted from lower attendance at NAPE Summer and NAPE Denver. Educational seminar fees decreased \$145,131 (24.2% reduction from \$600,908 to \$455,777) due to a decline in CPL review attendance because of a rule change. Member dues decreased \$93,797 (7.7% reduction from \$1,211,901 to \$1,118,104).

Expenses have decreased 65± from £⁰,656,²49 to £8,³49,878. The decrease in expenses is due in large measure to reduced food and beverage, speaker expense and fees, and virtual attendance for education seminars (60.9% reduction from \$690,168 to \$269,970), a reduction in publications costs due to ceasing the Landman 2 publication (43.7% reduction from \$467,453 to \$263,238), and a decrease in general and administrative expenses largely being contract labor and legal settlements (35.2% reduction from \$1,703,419 to \$1,104,603).

3.Statements of Investment Accounts

Investments as of March 31, 2017 are \$23,912,303, an increase of \$1,344,522 or 5.6% as compared to the same period last year. The change has been the result of unrealized and realized gains in the AAPL investment account in the amount of \$3,094,522 and transfers of cash of \$1,750,000 to the AAPL operating account, since March 31, 2016 \$3,094,522 and transfers of cash of \$1,750,000 to the AAPL operating account, since March 31, 2016.

I won't go into a great amount of detail on them but the AAPL's related accounts have increased since last year and the Education Foundation's assets have risen to \$3,641,591 and the Landman Scholarship Trust is up to \$6,711,731.

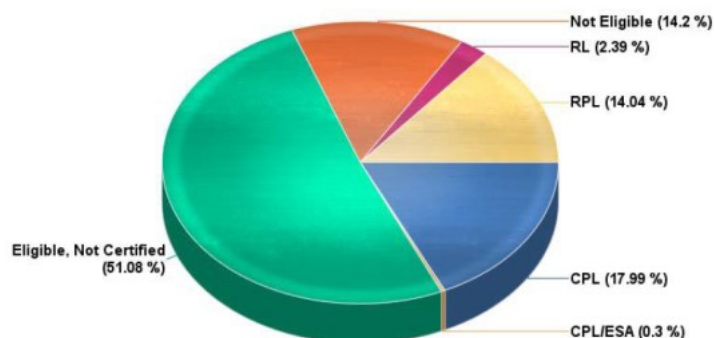

While AAPL does not track specifics on “Company” Landmen (usually work as employees for companies that drill or participate) versus Independents or “Field” Landmen (hard to define really since many field landmen now don’t really “go to the field” any longer to do title – it is done from images on their desktop at home) it is estimated that around 60+% of its membership are not Company Landmen but Independents. Since AAPL was originally formed to only be for Company Landmen, this “new majority” of members being Independents is an interesting statistic.

Speaking of Independents, since the Feds (and even many states) are still chasing after many of our members (and their clients and brokers) for money from all of them by alleging their “mis-classification” as ***independent contractors instead of employees***, (as they refer to it), Tom Havenstrite who is on the Tax Committee presented to the Board a proposal for a new way for AAPL to help those members. FYI, since Tom runs a very large brokerage company and been intimately plugged-in on this topic from his own experience, he knows a whole lot about this issue and his proposal was very detailed and well received.

Although some of our members may be unaware how big this issue has become, even though we have a new Administration in Washington D.C., the IRS and other Federal Agencies are still chasing MANY of our members for LOTS of money through alleged misclassification and the Tax Committee is the only thing that AAPL has at present to help members deal with these actions.

While it was thought that if members formed legal LLC's in their state and worked under it and its Federal Tax Identification number, and filed separate returns, it appears that even that is now being challenged and many brokers are now requiring LLC's be ramped up to an "S" or "C" corporation in order to get a contract with them.

Since the Tax Committee was not set up to specifically deal with this one issue, Tom's proposal was very specific in its mission, goals and policies, standards and application. The proposal to form an Independent Contractor Business Standards Committee would help members by having it set up to assist them in complying with governmental regulations through application of standardized acceptable business practices.

The Board will wait until the next meeting for the new Ex-Com to go through the proposal and look at possible ways that AAPL can move forward in its efforts to help those members. I could see that it may even eventually become a full-time job for an AAPL staff person to assist those members (who have complied with ALL the standards that AAPL sets forth) being scrutinized. While the Feds have been chasing after Independent Contractors for a long time, with both State and Federal budgets being pressured for more revenue, this has become an even bigger issue of late for our Independents.

Other AAPL News

Member Outreach and Advocacy:

- AAPL successfully killed a detrimental bill provision in the Texas House by overseeing AAPL's Texas lobbyist efforts resulting in removal of the provision from Texas House Bill 1325 that would have eliminated a sales tax exemption for landmen.
- AAPL directed Ohio lobbyist in ongoing efforts to add an amendment to the state budget bill to protect landman from a recent appellate court case which held that landmen must be registered as real estate brokers for certain mineral transactions.

Contract Center

- AAPL's Contract Center continues to attract new subscribers to our online negotiations platform. The Forms Committee is hard at work to develop new templates to be added and the first one which currently under development is the Participation Agreement.

With changes in our budget, dues increase, etc., AAPL appears to be in fairly good shape financially, we are cruising forward on a more "break-even budget" and should do OK if industry activity stays depressed like it has been the last year or so.

If you are planning on renewing your membership, please do so before July 1 as that will be the cutoff for the printed directory and it ranks as the number one most valuable membership things that AAPL does.

That wraps up my report for this quarter but if anyone wishes I can email you significantly more backup on most of the items in this summary report, just let me know. Also let me know if there is anything AAPL related I can look into or pass on at the next Board Meeting in September.

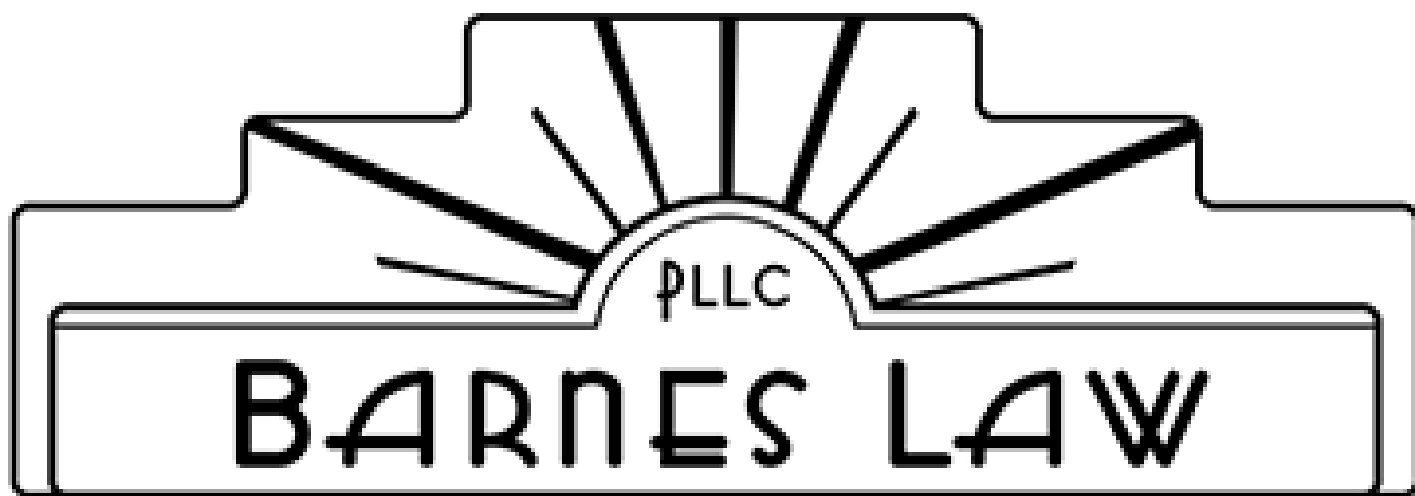
