SCHOLARSHIP AND ENDOWMENTS COMMITTEE

ARTICLE: "BUILDING GIANTS FOR THE FUTURE"

Tulsa was built on the shoulders of oil and gas giants, some of which still call the city home. These giants took calculated risks in a scary business, finding opportunity in an ever changing world and industry. There were wars, oil embargos, economic depressions, and the more ominous... dry hole. When one is casually reading "The Prize" on their Saturday afternoon (because who doesn't do this), it's apparent Tulsa was built on a foundation of ingenuity, perseverance and grit. As Tulsa landmen, we're proud of our city on the plains and like to see it grow and prosper.

In our profession, this "grow and prosper" aspect has meant adapting to change through technology. Where we once were using colored pencils to build maps and writing leases on typewriters, we're using fully integrated land enterprise systems (or excel for us small guys) and GIS for mapping. What once took months to complete, can be done in hours. Landmen of today require a broad set of skills, many of which require years of education.

Like our city, we as landmen want our industry and profession to grow and prosper. This is why our investment in education must be greater now than ever before. We're extremely lucky to have two of the premier Energy Management programs in the country. In 2013, TAPL recognized the need to support these programs and created Scholarship Endowments at both The University of Oklahoma and The University of Tulsa. Since the inception of the endowments, TAPL has granted nearly **\$50,000.00** in scholarships to up-and-coming landmen. Many of these landmen have gone on to significantly contribute to both Tulsa, TAPL and our greater profession in countless ways.

Every fall the Scholarship, Endowments and Awards Committee ("SEA Committee") attends day long interviews at both universities to identify students that meet the following criteria:

1. Candidates must be full-time regularly enrolled undergraduates majoring in Energy Management, with a preference for students from the Tulsa metropolitan area
2. Candidates must have a minimum GPA of 3.0 on a 4.0 scale
3. Candidates must have demonstrated financial need
4. Candidates must have an expressed interest in becoming landmen after graduation

The SEA Committee goes to great lengths to find qualified candidates that meet these stringent criteria because we believe it's the best investment for our member's dollars. The committee does not take this responsibility lightly and works closely with the programs to reward the most qualified candidates. At times, the programs communicate that one student has received an adequate amount of scholarships and asks the SEA Committee to re-evaluate the scholarship distributions. Again, the process is aimed at efficiently directing TAPL dollars towards the best investment in our candidates.

To-date, our association has raised a total of **\$181,342.10** of the **\$300,000.00** goal between the two endowment funds. This astounding sum of money has been raised through many individual and corporate donations, as well as TAPL fundraising events. Through the years, our TAPL board has been incredibly supportive and generous in continuing to help the SEA Committee raise these funds.

We are truly making a difference in the lives of these future landmen and the future success of our profession.

The SEA Committee is making a push in 2019 to close the gap in the remaining funding of these endowments and need our member's help. Once the endowments are fully funded, the annual income off the investments will be sufficient to award **\$10,000.00** per year in scholarships to the TAPL scholarship recipients. Members will see more communications in the future as we get closer to meeting this goal. We sincerely appreciate the continued support of our members and hope you can see the return in these investments by "Building Giants for the Future".

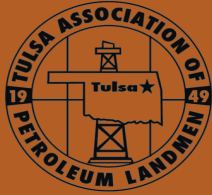
TAPL's 70th Year!

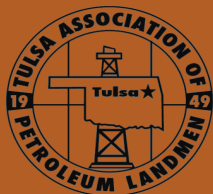
Yoder, near Hutchinson, the County Seat for Reno County, KS:

TAPL is pleased to announce that Oklahoma City University's Meinders Energy Association has invited TAPL Members to it's Brownbag Lunch Speaker Series featuring Jim Webster on Tuesday, February 5, 2019 at Noon.

Jim Webster will be discussing Value Chain Integration, a critical, but often overlooked discipline in the Upstream business by both Major and Independent E&P players. Look no further than the Permian Basin now with hydrocarbons ready to move but limited access to pipeline or alternative transportation, storage, and export facilities. This was a major area Mr. Webster managed by assessing and addressing with Phillips66 NGL Midstream's growth program. Major volumes of NGL were coming out of gas plants and crude production, but capital expenditures on value chain infrastructure had been flat for years. Not only transportation and storage, but fractionation, ethylene cracker capacity, derivative capacity, export facilities, and import facilities in international countries that product would have to go to were all imbalanced. Access to capital and external commercial relationships are a key to success.
