TAPL Members,

The Scholarship, Endowment, and Awards Committee (SEA) was honored to be able to recognize the 2018 – 2019 TAPL Award winners at April's TAPL Awards Dinner Meeting. The SEA would like to take this opportunity to further recognize these incredibly deserving recipients and their accomplishments.

COMPANY OF THE YEAR

TECOLOTE ENERGY, LLC

The Company of the Year award is awarded each year to recognize one company in particular that has made an outstanding effort towards TAPL's organizational goals, including sponsoring TAPL events and encouraging its employees to become involved in TAPL, amongst many other factors. This year, Tecolote Energy, LLC went above and beyond in regard to its many contributions to TAPL, and was more than deserving of this honor. Below is more information regarding Tecolote:



- Private oil and gas exploration and production company with offices in Tulsa, OK and Canadian, TX and 83 current full-time employees.
- Formed in 2015 with capital from the management team and Natural Gas Partners.
- The company is applying extended lateral drilling and modern completion techniques to the 16 stacked oil and liquids-rich Pennsylvanian age reservoirs that underlie its 210,000 net HBP acres in the 'POWER' play.
- Currently produces approximately 30,000 barrels of oil equivalent per day and operates over 1,200 wells in the western Anadarko basin.
- The company has set a number of records in its short history including drilling the longest horizontal lateral in the western Anadarko, the highest reported 30-day oil IP in Hemphill County, TX, and the largest six month cumulative production from a horizontal well in Hemphill County.
- Continues to seek opportunities to acquire and consolidate assets in the basin.

LIFETIME ACHIEVEMENT AWARD

KERBY HUNT

One of the highest honors to receive from TAPL, the Lifetime Achievement Award is annually bestowed upon an individual member of extraordinary character, and one whom has gone above and beyond during their career in the oil and gas industry. Since its inception, this distinguished award has been the memberships' way to recognize one Landman that has contributed countless hours of their time, donated insurmountable amounts of energy, offered their innovative expertise, mentored the upcoming generations of Landman, and who has contributed his or her efforts all for the greater good of TAPL. This year's Lifetime Achievement Award deservedly goes to Kerby Hunt.



Kerby Hunt graduated from Tulsa Edison High School in 1977 and continued his education at The University of Oklahoma where he graduated with a PLM degree. After graduation, he accepted a job with Reading and Bates which took him to both Houston and Denver before returning to Tulsa until that office closed. Subsequently, he went to work for Samson Resources and Plymouth Resources before starting Axis Exploration, LLC with John Arthur in 1995. As horizontal drilling became a complex reality for small producers, he joined the Management Team of Plymouth Exploration, LLC as the VP of Land until Plymouth sold to the South Korean Conglomerate, SK Innovation. Currently, he is the VP of Land at Triumph Energy Partners, LLC where they operate two rigs drilling in the STACK play in Blaine, Kingfisher and Canadian Counties in Oklahoma. He enjoys working, playing golf, and walking his Pitbull Georgia. He has been married to his wife, Allison, for 32 years. Together they have two children, Reider Hunt and Merritt Hunt, both of whom are landman and active members of TAPL.

LANDMAN OF THE YEAR

ANDREW GRIMM

Another incredibly prestigious honor awarded by TAPL, the Landman of the Year award recognizes an outstanding landman for his or her superlative contribution to the land profession, the oil and gas industry, TAPL, and the local community. It should be no surprise that this year's Landman of the Year is none other than Andrew Grimm!



Andrew Grimm is a Native Tulsan and graduated from Cascia Hall. After high school, he went on to earn a Bachelor of Business Administration from the University of Oklahoma. While at OU, he was a member of Sigma Chi Fraternity and currently serves as the Tulsa Alumni Chapter President as well as being a member of the University of Tulsa Sigma Chi Chapter House Corporation. Over the past 13 plus years he has worked for Continental Land Resources, Mid-Con Energy Partners and Wagon Wheel Exploration. In the summer of 2016 Andrew began a new venture as co-owner of Anchor Land Group. Anchor Land Group prides themselves on being a "Broker to Barrel" full land company providing corporate services and employment to many Tulsa Landman. Anchor has a staff of 30 employees with offices in Tulsa and Oklahoma City. He has been an extremely active member of TAPL since 2008. He has served as President (2016-17), Vice President, Secretary and Membership Director two times. Andrew was also instrumental in the organization of the TAPL 65th Anniversary Party. EMERGING LANDMAN OF THE YEAR

ELLIOT DOWLING

This award recognizes the hottest “up-and-comer” of the local oil and gas industry, and acknowledges one whom is considered to be a rising star amongst TAPL and abroad. This year’s Emerging Landman of the Year award goes to one of the most deserving young land professionals in the business, Elliot Dowling!

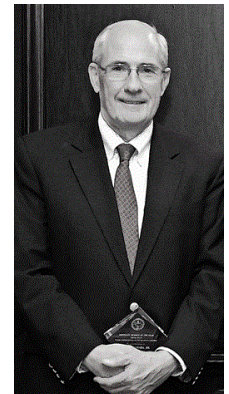


Originally from Dallas and a soft-spoken Texas longhorns fan, Elliot was wise enough to pursue his Energy Management Degree from the University of Tulsa. During his studies at TU, he was awarded the University of Tulsa Academic Scholarship, OERB Scholarship, Samson Scholarship, JMA Scholarship, Natural Gas and Energy Association of Oklahoma Scholarship and Devon Energy Scholarship. He also was involved with philanthropies, held numerous leadership roles in organizations and was a student member of both the AAPL and the TAPL mentorship program. After earning his Energy Management Degree from the University of Tulsa in 2014, Elliot accepted a role at a small Tulsa family-owned oil and gas firm where he generated significant value through self-sourced deals and attained increasing levels of responsibility. In May of 2018, he joined a larger Tulsa oil and gas firm that actively drills in Wyoming where he is currently an integral part of the firm’s drilling program, with nearly 30 wells drilled before his first anniversary with the firm. His professionalism, strong work ethic and general gregarious nature bonded him as a key contributor to the team. In addition to his professional focus, he continues his active involvement with the TAPL with his work on both the Scholarship, Endowment and Awards Committee and also the Communications Committee.

ASSOCIATE MEMBER OF THE YEAR

STEVE McNAMARA SR.

This award recognizes one individual associate member who has gone above and beyond in his or her contributions to the TAPL organization. This is an oil and gas professional who you will undoubtedly see at almost any TAPL event, and who is incredibly involved within the organization. Deserving of this recognition is none other than Steve McNamara Sr.!



Steve McNamara Sr. is a third generation Tulsan. One of his grandfathers was an executive with Sinclair Oil Company and another discovered the Earlsboro field in Pottawatomie County, Oklahoma. Steve attended the University of Notre Dame and then the University of Tulsa Law School, graduating in 1978. He has been practicing oil and gas law since 1979. He was formerly chief counsel of Reading & Bates Petroleum Co. in Tulsa from 1980 through 1987. He was primarily responsible for the company's domestic exploration and production activities. Steve worked extensively on Reading & Bates' interest in the S.E. Sumatra and N.W. Java concessions of Indonesia and on the initial exploration and development of the Harriet oil field offshore western Australia, including platform construction, infrastructure and related development. He also handled transactions in Egypt, Colombia, Peru and Argentina. Since leaving Reading & Bates in 1987, Steve has represented dozens of independent oil and gas producers in Oklahoma and elsewhere. He maintains an active Oklahoma Corporation Commission practice and has been involved in several complex cases involving gas measurement, gas processing and natural gas liquids. He has served as acquisition project coordinator on several Woodford Shale and Hunton de-watering projects and maintains an active mediation and private arbitration practice in oil and gas related matters. Steve is considered to be the oil and gas “go to guy” for mineral and leasehold owners as well as operators, both large and small. He and his wife Mary have continued supporting Tulsa by raising the 4th generation of McNamara’s: Steve Jr, Kevin, Patrick and Libby.

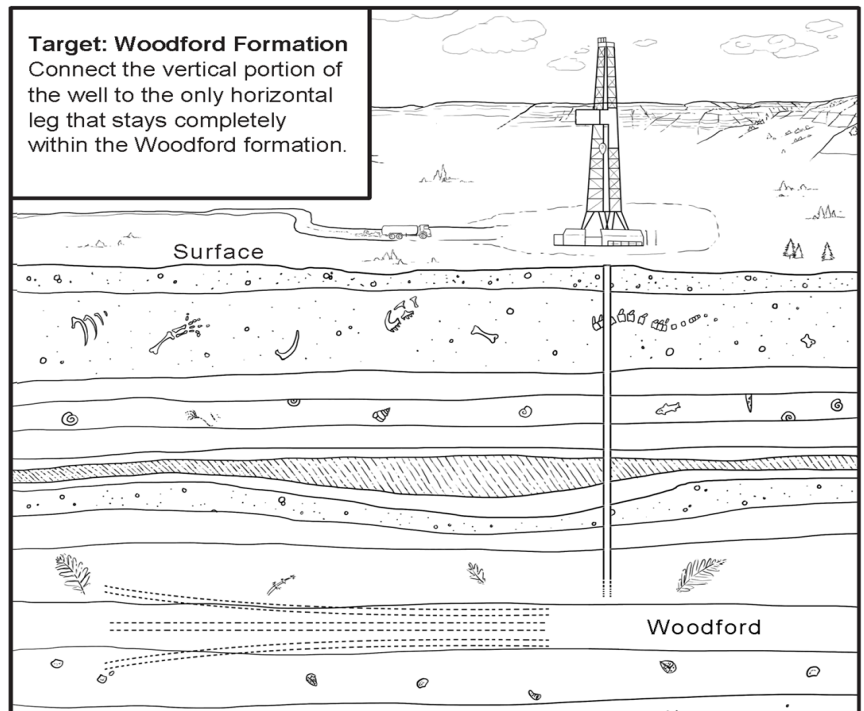
