ASK THE ATTORNEY

ASK THE ATTORNEY

Welcome to “Ask the Attorney.” This new monthly segment will provide TAPL members an opportunity to get their energy related legal questions answered—without that hefty legal bill. Whether you have a unique title issue or just a general legal question, this segment will provide you guidance. Each month I will select one submitted inquiry and provide an analysis.

QUESTION:

A patent appears of record from one of the Five Civilized Tribes wherein the patent sets forth described lands, less the amount in specified acreage embraced within a railway right-of-way strip. Does the railroad company own the minerals underlying the railroad lands?

ANSWER:

In Oklahoma, a railroad company’s ownership to the lands in which its rail lines are located can be (1) in fee simple, (2) a limited determinable fee, or (3) an easement. In determining the type of ownership, the first step is to identify the authority under which the railroad occupied the lands. Here, because there does not appear to have been a conveyance into the railroad, we will assume the railroad was established through an act of congress.

There are multiple acts of congress, both general and specific, that “built” railways. In interpreting these acts, courts have uniformly held that the rights granted the railroad grantees were easements for right-of-way, not fee simple ownership. The rationale for these holdings can be found in *United States v. Magnolia Petroleum Co.*, [110 F.2d 212](#), 218 (10th Cir. 1939).

The court in *Magnolia* analyzed the Act of April 26, 1906, entitled “An Act to provide for final disposition of the affairs of the Five Civilized Tribes in the Indian Territory, and for other purposes.” The decision established (1) that the rights acquired by railroad companies through acts of congress are only “in the nature of an easement”; (2) that upon abandonment, the interests would revert to the owners of the servient estate (being the lands subject to the easement); and (3) that the tribes had no further claim to railroad lands reserved from allotments.

Two notable exceptions exist to the rule that the mineral rights underlying a railroad vest in the owners of the abutting servient estate. Both of these exceptions stem from the Act of April 26, 1906. The first exception is that under the Act of April 26, 1906, the railroad company had the right to acquire the easement at a valuation to be determined by the Secretary of the Interior. Despite this exception, in my 10 years of running title I have never encountered, nor am I aware of, a single instance where a railroad company purchased its easement.

The second exception occurs where the railroad lands are located within a municipality. In this instance, the mineral rights underlying the railroad are vested in the towns, not the abutting servient estate. This exception was made clear in *Chickasha Cotton Oil Company v. The Town of Maysville, Oklahoma*, 249 F.2d 542 (10th Cir. 1957). The court in *Town of Maysville* again turned to the Act of April 16, 1906, which provides that if “any railroad or railway company fails to purchase the land upon which it holds an easement prior to that date, title will vest in the owner of the legal subdivisions of which the land so abandoned is a part, **except where lands are within a municipality when title will vest in such municipality.**” [Emphasis added]

AAPL DIRECTOR'S REPORT FOR THE TAPL

The AAPL Quarterly Board Meeting was supposed to be held in Napa Valley, California but due to restrictions from Covid-19 AAPL decided to hold the Board Meeting virtually. The following notes are only a portion of the meeting. Should any member like to discuss more in detail, then please feel free reach out to me.

AAPL By The Numbers

- 12,003 AAPL members (as of 11/30/20 – compared to 14,900 same time last year)
- 4,932 CPL's, RPL's, and RL's (as of 11/30/20 – compared to 5,277 same time last year)

Education

- AAPL Field Landman Seminar via online video January 21, 2021 at Noon (CST) and is free! Sign up.
- FREE monthly AAPL seminars are on Thursday's. Be on the lookout!
- Hope everyone that took the CPL/RPL Exam in Tulsa on Friday, November 13, 2020 passed! Special thanks to Michael Schooley and Alex Robinson for helping to proctor the exam. Glad we were able to host this in Tulsa.
- **Recertification Extensions:**
 - RL's – Certification Committee authorized a 90-day extension with certification expiration dates of 3/31/20 – 12/31/20 to earn required recertification credits.

Financials

As the negative impacts continue from Covid-19, AAPL believes we will experience a significant downturn that may last up to two years. The loss of Summit NAPE, sponsorships, membership, etc. was significantly more than anticipated but our gains from our investment account will help limit this loss. AAPL believes that we will have a net loss of about \$3 million for this fiscal year. Fortunately, saving and investing over many years have allowed us to weather these difficult times. No plans to cut any benefits to the members. The following are accounts associated with the AAPL and the dollar amounts as of 9/30/20:

- Total Assets = \$40,581,529 (up from \$38,460,078 as of 9/30/19)
- AAPL, Inc's Investment Accounts = \$33,875,859 (up from \$30,100,811 as of 9/30/19)
- AAPL Educational Foundation, Inc. = \$4,714,943 (up from \$4,375,164 as of 9/30/19)
- Landman Scholarship Trust = \$8,367,228 (up from \$7,698,712 as of 9/30/19)

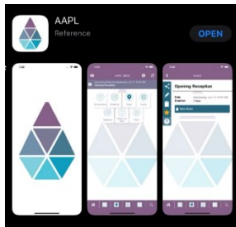

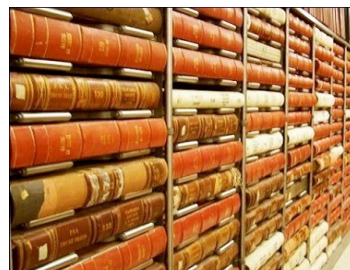

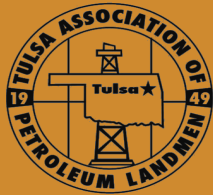
